### **LONG BRANCH**

- **180's Outreach Program** centers on culturally relevant trauma-focused counseling for domestic violence and sexual violence survivors.
- Services are available free of charge in English and Spanish. Services available include individual supportive counseling, group counseling, immigration services, and case management.
- Counselors can assist in applying for domestic violence protection orders, Address Confidentiality, and VCCO applications.
- Counseling is available in person, virtually and by phone.

## **FREEHOLD**

- **180's Family Justice Center** offers coordinated services for victims of domestic and sexual violence in one safe place to meet all survivors' immediate needs.
- Designed to reduce barriers and expedite services by bringing government and non-government agencies together.
- Family court liaisons assist victims in Family Court, including applying for restraining orders, legal services, individual and group counseling, and court accompaniment.
- Counseling is available in person, virtually and by phone.

#### **HAZLET**

- 180's Domestic Violence Counseling program offers trauma-informed individual supportive counseling, group counseling, and monthly financial empowerment workshops.
- Our counselors work with those who have left an abusive relationship and or those who are experiencing abuse at home.
- Counselors can link with our Family Justice Center to assist in obtaining domestic violence protection orders, Address Confidentiality, VCCO applications, and all 180 services.
- Counseling is available in person, virtually, and by phone.
- 180's Sexual Violence Counseling program centers on trauma-informed counseling for the individual and family members of those who have experienced sexual assault.
- Groups are available for men and women weekly.
- In connection with our Family Justice Center, advocates can assist in obtaining a sexual violence protection order and any referrals needed.
- Counseling is available in person, virtually and by phone.
